Please find the enclosed NANI audit request for Q4, 2020.

As you know, we combined the NANI and CADNET networks into one beginning January 1, 2021. Because you were running the NANI Network separately in Q4, 2020, we are only auditing that one quarter to allow us to close out the NANI Network and provide you with your earned rebate for that last quarter of 2020 as a NANI participant.

This will be the last audit request sent for the NANI Network itself. Going forward we will be auditing the combined NANI & CADNET Network as one. The new network will be called Advertising Distribution Services or ADS. You will notice that we will transition to the new branding of the ad list over the next couple of weeks.

The ADS Network will still send verification (audit) requests semi-annually. We will send the first request out in July, which will be for Q1 & Q2 of 2021.

We appreciate your patience during this transition period and look forward to working with you on the ADS Network going forward!

Include a copy of your professional circulation audit or postal statement for the audited period. All verification audits must be from within two years to be eligible for a rebate check.
